#### Section II: Reading & Responding (40 marks) – 10%

#### Part A: 25 marks

You will read **TWO** texts in Chinese based on the topics above. You will be required to respond in English to questions phrased in English.

#### Part B: 15 marks

You will read **ONE** text in Chinese based on the topics above. You will be required to respond to a question phrased in English by writing approximately 250 characters in Chinese.

#### Section III: Writing in Chinese (15 marks) - 10%

You will be required to respond to **TWO** questions phrased in English. One question requires a response of approximately 90 characters in Chinese and the other question requires a response of approximately 250 characters in Chinese. The questions will indicate the purpose, context and audience for your responses.

#### Feedback provided

The teacher will provide written feedback outlining strengths and areas for improvement to build on knowledge, understanding and skills for future learning.
