<u>Assessment 4 – Written Paper</u>

Section I: Listening & Responding (25 marks) – 10%

You will hear **EIGHT** texts in Japanese based on the topics above. You will be required to respond in English to questions phrased in English.

Section II: Reading & Responding (40 marks) – 10%

Part A: 25 marks

You will read **TWO** texts in Japanese based on the topics above. You will be required to respond in English to questions phrased in English.

Part B: 15 marks

You will read **ONE** text in Japanese based on the topics above. You will be required to respond to a question phrased in English by writing approximately 400 *ji* in Japanese.

Section III: Writing in Japanese (15 marks) – 10%

You will be required to respond to **TWO** questions phrased in English. One question requires a response of approximately 150*ji* in Japanese and the other question requires a response of approximately 400 *ji* in Japanese. The questions will indicate the purpose, context and audience for your responses.
