Assessment 4 – Written Paper

Section I: Listening & Responding (25 marks) – 10%

You will hear **SEVEN** texts in Spanish based on the topics above. You will be required to respond in English to questions phrased in English.

Section II: Reading & Responding (40 marks) – 10%

Part A: 25 marks

You will read **TWO** texts in Spanish based on the topics above. You will be required to respond in English to questions phrased in English.

Part B: 15 marks

You will read **ONE** text in Spanish based on the topics above. You will be required to respond to a question phrased in English by writing approximately 200 words in Spanish.

Section III: Writing in Spanish (15 marks) – 10%

You will be required to respond to **TWO** questions phrased in English. One question requires a response of approximately 75 words in Spanish and the other question requires a response of approximately 200 words in Spanish. The questions will indicate the purpose, context and audience for your responses.
